Water Main Breaks/Repairs/Excavations	Thirty-six (36) water main breaks in the First Quarter of 2019 compared to twenty-seven (27) in the First Quarter of 2018. The depth of frost this winter due to the prolonged cold period was a contributing factor to increased failures.
Solid Waste	Recycling diversion in the first quarter of 2019 increased to 21.2% compared to 20.3% in the first quarter of 2018. Residential waste tonnage decreased by 8.9% during the same comparison period.
	In comparing first quarters, year over year, the total landfill tonnage received, increased by 127 tonnes or 2.1%.

32 employees attended our first Wellness Fair. Parks & Recreation, Sun Life Group Benefits and Pension were on site at Yara Centre. 19 employees met with retirement consultants from Sun Life.
